For classes beginning June 29 and July 11, mail in registrations accepted April 15 through June 17. After June 17 registration is in person only. In person registration at **Tiger Mountain CHS: June 20, 21, 22, 23 (9A-3P) and June 24 (9A-12P)**
In person registration at **Issaquah Middle School on Tuesday, June 28 (9A-12PM)** the day before classes begin. Schedules may also be picked up on this day.

Refund Policy: For classes starting **June 20** – cancellations on or before June 6 will be issued a full refund. No refunds after June 6. For classes beginning **June 29 or July 11** - cancellations on or before Tuesday, June 28 will be issued a full refund; cancellations on Wednesday, June 29 will be issued a refund less a \$25.00 processing fee. Refunds on June 30 will be issued at 50% of tuition. No refunds will be issued after June 30, 2011.
