AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of Issaquah School District No. 411 from September 1, 2017 through August 31, 2018.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended August 31, 2018, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Apportionment – Big Picture enrollment reporting at Gibson Ek High School
- Travel – review of employee reimbursements and Associated Student Body (ASB) field trip applications for compliance with District's Regulations Manual
- Student Store activities – cash receipting at Skyline High School
- Cash receipting – Cash counts at Newcastle, Sunset, Creekside, Endeavour, Sunny Hill, and Clark Elementary Schools
- Payroll – review of payroll process for direct deposit changes
- Use of bond proceeds – review of controls and test support to ensure bond proceeds were spent for an allowable purpose
- Procurement – compliance with public works projects awarded and prevailing wage requirements; review of change orders

INFORMATION ABOUT THE DISTRICT

Issaquah School District No. 411 serves approximately 20,000 students in kindergarten through 12th grade in the foothills of the Cascade Mountains. The District operates three comprehensive high schools, one innovative public high school, five middle schools and 15 elementary schools. It also operates the educational section at the state's Echo Glen Children's Center in Snoqualmie.

An elected, five-member Board of Directors governs the District. The Board appoints a Superintendent to oversee the District's daily operations as well as its approximately 2,400 employees. For fiscal year 2018, the District operated on an annual budget of approximately \$315 million.
