
Filling out Online Forms in Family Access

This is the process for filling out an Online Form in Family Access.

1. You must have a parent or guardian account in Family Access to check in your student. You cannot do so using a student account. If your student has more than one family, only the parent or guardian at the student's primary residence can do this process. If you have forgotten your Family Access ID and password, use the 'forgot your login\password option' to receive an email (email address of record) with your login ID and a link to reset your password.


